### **MINIMUM SERVICES OF THE FUNERAL DIRECTOR AND STAFF:**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations.) This fee includes the following: Non-declinable services of Funeral Director and Staff - Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement online conference with family or responsible party; preparation and filing of necessary authorizations and permits; recording vital statistics. **\$ 700.00**

**Refrigeration Charge** California law requires refrigeration of remains not embalmed, if disposition is not within 24 hrs. **\$ 50.00**

### **TRANSPORTATION:**

➤ **Local transfer of deceased within San Diego County to our facility as indicated below.**

Includes: Border of Mexico to Riverside and Orange County Line south to north, Coast of San Diego County to Escondido, El Cajon and zip code 91978 west to east. A flat rate of \$150.00 will apply, plus \$3.50 per mile one-way beyond these boundaries. **\$ 350.00**

➤ **Transfer from private residence or board and care second man charge** **\$ 75.00**

➤ **Delivery of Cremated remains within 30 miles of service area** Additional charge of \$3.50 per mile one way beyond service area **\$ 150.00**

### **DIRECT CREMATION ONLINE, BY EMAIL, OR (BY FAX within USA)**

If you want to arrange direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials with or without an outside covering. The containers we provide are cardboard. Our charge for direct cremation without ceremony and at our convenience includes: Local transfer of remains, refrigeration, cardboard alternative container and cardboard container for ashes, crematory charges up to 200 pounds, cremation to take place within 10 days after permit for cremation is obtained, forms are completed properly, and payment has been received, and minimum services of staff. Online (or fax within USA only).
